EMPANELMENT OF AGENCIES

Scope of Work

Supporting Local Self Government Institutions in the State of Kerala in design, installation, operation and maintenance of Modern Slaughter house. The scope includes annual maintenance of the system also. The proponent should follow proper guidelines and norms as prescribed by KSPCB. The empanelment will be to ease out the complications in selection of expert agencies for the purpose. The empanelled agencies shall be engaged for the task by the LSGIs through prevailing tender procedures.

Eligibility Criteria

1. The interested entity should essentially meet the following eligibility criteria:
 - a. The agency must possess minimum 3 years experience, expertise and manpower in design, construction, installation, operation and maintenance of Modern Slaughter House.
 - b. Should have a valid Service Tax/VAT/TIN number for the line of business the entity is engaged in.
2. The required documents such as technical design of the Modern Slaughter House, its performance details along with explicitly supporting the past experience, list of existing and past clients with details of services offered, details of similar projects executed, with copies of agreements/work order completion/ satisfaction certificates, CVs of key personnel and other related details to verify all eligibility criteria must accompany the EoI.

Preparation for submission of EOI

- a) The entity/bidder shall ensure that it fulfills the eligibility criteria and other essential conditions.
- b) The EOI complete in all respects must be submitted together with technical proposal and other requisite information and annexure(s). The EOI should be free from ambiguity, change or interlineations. Incomplete EOI will not be considered and is liable to be rejected without making any further reference to the entity.
- c) The EOI shall be duly signed on each page by a person authorized by the entity. Documents of the entity authorizing such person must accompany the EoI. Suchitwa Mission reserves the right to reject outright any EOI unsupported by proof of the signatory's authority.
